SESSION 1 – NOV. 28 AT 8:30 A.M.

NRECA Course 971.1: "Governance Challenges of the Evolving Distribution Cooperative" – Bryan Singletary

Course Description: The distribution cooperative marketplace is changing faster today than at any time since our foundational period. Distribution cooperatives' relationship with their members are transforming due to changing member preferences, new business models, new technologies and third-party applications. This course focuses on how these changes call for different ways of thinking, data collection and analysis at the board level if boards are to fulfill their oversight responsibilities and strategic vision.

Key Topics Include:

- Recognize the drivers of the changing industry landscape writ large.
- Discuss how the evolving energy landscape impacts governance and the way a board performs its oversight function.
- Envision where they would like to see their co-op be in 5-7 years
- Identify specific data necessary to inform a recommended course of action.

SESSION 2 - NOV. 29 AT 8:30 A.M.

NRECA Course 901.1: "Rules and Procedures for Effective Board & Membership Meetings" – Colette Collier Trohan

Course Description: This course provides an overview of what directors need to know about parliamentary procedure to become more effective participants in board meetings. Participants will understand the purpose and use of proper procedure in business meetings and become familiar with the basic structure and content of Robert's Rules of Order.

Key Topics Include:

- How parliamentary procedure helps ensure effective, democratic meetings.
- The essential rules of debate.
- The key elements of agendas and minutes.
- Procedures for voting, elections and secret ballots.
